## CONFERENCE /ITEMS OF DISCUSSION-

Discussion of Businesses in Redevelopment Areas (Terry Carr and Larry Cardwell) Mr. Cardwell discussed the following:

**Auto Body Shop** – 4800 North Crescent Blvd.(next to IQ Computing) the potential tenant would like to operate an auto body shop in this location. This is the same use that the previous tenant had in the building. *Committee was ok with this moving forward* 

**RPC Driveline Services** – 7929 River Road (Previously Jay's Tires) The primary use of this property is for sales of auto parts and accessories. The proprietor would like to include U-Haul truck rental to this location. *Committee was ok with this moving forward* 

In His Presence Ministry – 5635 Westfield Ave. 2 suites totaling 1600 square feet. (Professional building between Merchantville and Lexington Avenues) this church was notified that they did not have a certificate of occupancy. They have however been in operation at this location for over 10 years. *Committee was ok with this moving forward*

## **PUBLIC COMMENT**

Mayor Kneib opened the floor for public comment

<u>Susan Bryant – Cedar Avenue</u> commented on the Township's Library and stated that she had at one time been the Director. She commented that the Library is not keeping the pace with the needs of the Community. She also commented that the Library is one of the busiest in the state. She stated she knew it was budget time and stated she would ask Committee to be liberal with giving to the Library. Ms. Bryant commented that the rug is at least 40 years old, they need a new air conditioner, and that with things becoming more digitized they need to update their digital and audio books.

Mayor Kneib commented that all the Library needs have been met with an additional \$80K more. The air conditioner is the only thing they haven't gotten that they've asked for.

Committeeman Killion commented that they are making efforts to do a lot of things

Ms. Bryant commented that there is a 1:1 match grant for libraries for such upgrades and suggested the Township contact Senator Beech and Assembly Reps Greenwald and Lampitt.

Joanne Young - Park Ave. asked about the "Mart Site"

Mayor Kneib commented that we "should all be walking around with smiles on in 24 hours." He stated the hard closing is scheduled for tomorrow April 7<sup>th</sup>.

Ms. Young then asked about the Energy audit and if the Township would be getting any notification in the mail. She also questioned if you can opt out anytime?

Mr. Grochowski stated the two meetings would be on the 14<sup>th</sup> and 18<sup>th</sup> of this month and residents could opt in and out at any time. He also explained that it is the generation side of the energy bill which could never be above PSE&G cost and that the saving is at 13%. The transmission side is still PSE&G.

Mayor Kneib asked for any other comments from the public, there was none. Mayor Kneib stated that he wanted to report on the comment that Mr. Chaplick who commented that his street had not been plowed and that he had loss a couple days of work because of it. Mayor Kneib reported that the records had been pulled and commented all the trucks have GPS and that not only had his street been plowed but that it had been done 5 times.

Mayor Kneib also commented that he would be having a meeting with Realtors within the Township, and Committee would be meeting on the signage and colors of signs, etc. soon.

Committeeman Killion moved a motion to close the floor to the public

Committeeman Figueroa seconded the motion An affirmative 4/0 voice vote was recorded
