CONFERENCE / ITEMS OF DISCUSSION-

<u>Roger Wilco – 1001 Route 73</u> (Next to McDonalds). The owners of the property would like to make the following site improvements: install a pole barn 20 x 30 feet at the rear of the property to stage inventory, remove existing pavement areas and add new ADA compliant accessible parking spaces and ramps. (Representatives of the company will attend)

There was a lot of discussion about the exterior of the building and the lack of cleanliness.

Jamie was present to represent Roger Wilco who stated the family has owned the building since 1986 and that he has been present at that location since 2010.

Committee unanimously stated that at this time they would not be given the approval to move forward and commented that for the next 6 months they should work on keeping the location clean and free of debris. They suggested maybe hiring someone to keep the location clean.

Comments were made that the accumulation of pallets and cardboard area fire hazard. Mayor McBride and Committee asked the Administrator to contact Code Enforcement to keep a closer eye on the location.

"Your location in this Township looks like you don't care it's not the same attitude as your other locations. We feel as though you're telling Pennsauken we don't care about the Township we just want more produce to be sold." "Your business isn't only inside, it's also outside"

The Engineer for Roger Wilco was also present and commented that a site survey is currently being worked on and they will work on the parking and an enclosed trash area.

AGENDA ITEMS

Clerk Padalino informed Mayor & Committee of the upcoming ordinance for the next meeting.

1) UNFINISHED BUSINESS/ORDINANCES ON SECOND READING:

ORDINANCE NO. 2017:09

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF PENNSAUKEN, CHAPTER 243 THEREOF, ENTITLED "PROPERTY MAINTENANCE" (Second Reading/Public Hearing-June 28)

PUBLIC COMMENT

Mayor McBride opened the meeting to the public for comment.

Ellyn McMullen of Palace Court asked for an update on Haddon Point's ground breaking.

Mayor McBride commented the ground breaking is scheduled for June 28, 2017 at 11:00 am

Scott& Terry Murphy of Bryn Mawr commented about the proposed parking lot extension for the Bayada complex and commented that Bayada only contacted 4 property owners about changing the zoning.

The Murphy's commented that they were out of town when the meeting took place and that the other neighbors didn't really understand the letter. Bayada is requesting additional parking spaces which would infringe upon the privacy of their back yards. Mr. Murphy commented he might have a potential solution that would be to remove the small islands which he was told were needed for environmental purposes but was never told what that was.

Mr. Murphy was told that a meeting would be set up by the Administrator and Bayada's representatives to discuss his concerns and maybe a possible solution.

Diane Johnson of 45th Street requested the parking issues be looked at again. She described an incident that happened on 47th and High street with a fire truck.

Vincent Squire of Rogers Avenue spoke about an incident that happened to his neighbor on Father's Day and a generator being taken from off his front porch. He spoke about a declining police force and 12 hour shifts but not enough coverage within the Township. He continued that the perpetrators are known criminals and requested the Township do something about it. His suggestion was to place their photos on the township website and send notification to the neighbors.

Township Attorney Joyce reminded him of the absent incarceration bail reform and having to believe in the system. Mr. Joyce also commented that the police are always receptive to calls.

Mayor McBride reminded him that we have a neighborhood watch that meets every 2nd Wednesday of the month at the police station, of which anyone can join. She also commented on Bail Reform.

Diane Johnson of 45th Street commented that she gets text about things happening in Palmyra and Cinnaminson but not Pennsauken.

Committeeman Orth commented that he and the Police are aware of the system but that the Chief of Police is not comfortable with it for some reason.

No others wished to comment.

Committeeman Orth moved a motion to close the floor to the public Committeeman Taylor seconded the motion
