(The professional building between Merchantville and Lexington avenues) The applicant was previously approved for administrative office for a Home Health Care agency, this is an additional application with an upgraded use to allow for health training classes utilizing 3 training rooms. The trainees which approximately 95% are approved by NJ Workforce Development gain skills to provide psychosocial, physical care and recreational activities to individuals that are physically or mentally ill, injured, disabled or confined to bed or wheelchair in nursing homes, hospitals and other settings. This is an existing tenant that is looking to expand their space to provide the training for their staff so that the staff can perform the services required.
