Twin Oaks Community Services – Whitesell has the property. It is a charitable organization and it provides prom dresses for kids in need. They would be open normal business hours. It would be located at 8021 Crescent Bldv, Suite 7. **This May Move Forward.**

Mangold Lawn and Landscape- this is a lawn and landscape business.

Ms. McBride does not want their lawn signs all over. Mr. Cardwell and Mr. Carr will speak with them about this. (470 N. 37th St. at River Rd.)

This May Move Forward.

Mr. Cardwell stated that there had been the first meeting with the new chamber of commerce. It was well attended. He said that prior to January 1 the BIG council was one bank account and other bank account was All Around Pennsauken.

Aceto Auto Repair- this business wanted to rent U-Hauls and was asking the Township Committee to reconsider the U-Haul rentals at their location.

Mr. Aceto was present and said he wanted to bring U-haul back to subsidize his business. He lost his dad who used to help and he can not afford another person of his Dad's caliber to help with the business.

Mayor Taylor is concerned that Rt. 130 will be junked up as it is a gateway.

Mr. Aceto stated that he is putting fresh top soil in. He would rent the vehicles out. They would not be on lot for more than a couple of days. He would keep perhaps 3 or 4 vehicles there.

Committeewoman McBride said that we currently have a large U-haul business and Elite was parking a lot of vehicles on Route 130. We do not want 130 to be a parking lot. She stated that the Township Committee denied it and he kept trucks and signage there. She asked if there was any back lot parking?

Mr. Joyce said perhaps he can park trucks be behind the building or on side.

The U-Haul rentals would get him about \$ 1500 a month and it helps with rent.

Mr. Aceto said he has been at that location for 12 years.

He stated in a response to a question from Committeeman Killion that he has not done any upgrades to building.

Committeeman Killion said that the lot and grass do not look good. We are business friendly and said that if the Township Committee says yes he thinks only minimal things will happen.

The Township Committee said that they need to see some effort from Mr. Aceto. The Township Committee wants the Police Traffic Division to look at the location for potential traffic issues and pull records on any code issues on the property.

Mayor Taylor asked if we can put a time line on it after they make improvements and can our decision be reversed. He would like Mr. Aceto to speak with Sgt. Sulzbach and come in with conceptual plans.

The Administrator said Mr. Cardwell or Mr. Carr should call Sgt. Sulzbach at the Police Department.

Mr. Rodriguez arrived and said that he has been cited by the Code Department, he has an appliance store on Marlton Pike. He said that things are delivered at night and he would like to put things out to show what he sells. He would make sure that things would be off sidewalk by closing.

Mr. Rodriguez said he has been there between 10 and 12 years.

Mayor Taylor said that years past there were complaints from neighbors.

Mr. Rodriguez stated that he buys haul- aways. He has a place in Cherry Hill also. He said that he puts stuff outside so people knows he is there.

Committeeman Killion said that there is not a problem with a couple of items being out that he is going to sell, but take in at night.

Mayor Taylor said that he would have the Administrator to reach out to the Code Department.

He said that the appliances outside will be ready for sale. Mayor Taylor said we will review this.

The Township Committee said that appliances cannot be dropped off at night.
