Mr. Carr and Mr. Cardwell presented the following.

KAR Towing – 2250 Sherman Ave. (north of the Wawa on Rte 130) The site would be an office only for a towing company.

Action Staffing Group – 4926 Westfield Ave. (Next to Rite Aid) This location would be for a staffing company office.

## Committee WAS NOT okay with moving forward

**Daycare** – 6325 South Crescent Blvd. *(behind the check cashing site)* This perspective day care would have up to about 90 children plus a staff of 11.

## Committee is okay with this moving forward

**Twin Oaks Community Services** – 8021 North Crescent Blvd. (next to Ivystone Assisted Living) This would be for temporary charitable sales event consisting of Prom Dresses.

### Committee is okay with this moving forward

**eSupplements LLC** – 9401 North Crescent Blvd. *(next to Discount Harrys)* The location would be used for storage and distribution of supplement products such as: work out supplements, appetite suppressants, diet pills etc...

Committee is okay with this Committeeman DiBattista recused himself

#### Mike Galante - Hotel on Rte 130

<u>Deputy Mayor Taylor</u> began by commenting that they were asked to come back in because last month they came in and where given the ok to go before the Planning and Zoning boards. The neighboring residents have come in stating that there were surveyors on their properties without permission. He also commented that they put Committee in a bad position.

Committeewoman McBride commented that had the surveyor asked permission there may not have been such a uproar with the residents. She commented that they never mentioned when they were inform of Committee before that they were contemplating offering to purchase homes. She stated that now they seem untrustworthy.

Committeeman DiBattista commented that he was present the night they came before Committee and even though he wasn't on Committee at the time he didn't remember any mention of a four story building nor the possibility of purchasing any neighboring homes. He commented that he is not happy with the way they went about this and they still need to go before Planning & Zoning Boards.

Mr. Galante commented that he had a letter from the Surveyor that states they asked for permission. He apologized on behalf of the surveyor if they are giving them half-truths. They were told to ask for permission. He also commented that the owner did solicit homeowners, but that he only spoke directly one homeowner.

Several property owners were present and upset with no contact from the owner about surveyor and other things.

Committeewoman McBride suggested that they consider a community meeting

<u>Deputy Mayor Taylor</u> explained to the property owners that through the Zoning and Planning Board process they have to be notified about the meeting and they would have an opportunity to voice their concerns.

Mr. Padalino, Township Clerk reminded Committee that at the meeting on the  $21^{\rm st}$  there will be to two Ordinances on the agenda for second reading and public comment.

<u>Deputy Mayor Taylor</u> commented that nothing has changed with the Township and County and he will have someone go out first thing in the morning to inform them they should be using Sherman Avenue and to find out what type of business they are.
